

Data privacy policy

Data collection and data processing

Personal data is considered to be individual details about personal or factual circumstances, such as name, address, or email address and password. Personal data is only collected if you provide it voluntarily in the context of setting up an account. We use, without your express consent, the data you provide exclusively for the processing and set-up of your account. Data with which you provide us voluntarily in the restricted members' area is visible to all members for the purposes of enabling contact ("Networking"); this data will be saved for the duration of your membership and will not be used for purposes beyond those stated above. Upon deletion of your account, your data will be blocked for further use and deleted.

Revocation option

The data is collected, processed and/or used by us solely in accordance with the applicable data protection provisions. Your consent for data collection/saving/processing and/or use can be revoked by you at any time with future effect by sending an email to jdzb@jdzb.de

Disclosure of data

We use your personal information only for the purposes stated above. Data will not be passed on for advertising purposes. Moreover, data will only be passed on to the extent that we have your consent to do so. Personal data will be passed on to public bodies and authorities if we are obliged by law to do so.

Use of cookies on www.jdzb.de

To make visiting the site attractive and to allow the use of certain functions, we use so-called cookies on various pages. Cookies facilitate use of the platform. Cookies are small amounts of data that can be stored on the computer of the user when using the platform. Cookies are used to create internal user profiles, including for the creation of anonymous user statistics, and to optimise the user-friendliness of our pages. The cookies used by us are deleted again after the end of your browser session, after closing your browser (so-called session cookies). We do not use other cookies that remain on your device (persistent cookies). You can configure your browser so that you will be informed about the placing of cookies, and can decide to accept them or to exclude the acceptance of cookies generally or in certain cases. The cookies used by us cannot cause any damage to your computer. If you do not want to use cookies, you can prevent them from being stored on your computer. This may mean, however, that certain functions of our site are restricted or no longer usable.

Use of Google Analytics on www.jdzb.de

We use Google Analytics, a Web analysis service of Google Inc. ("Google"). Google uses cookies. The information generated by the cookie about the use of the website by the user is generally transferred to a Google server in the USA and stored there. Google will use this information on our behalf to evaluate the use of our website by visitors, to compile reports about the activities within this web presence and to provide us with further services connected to the use of this website and internet use. For this purpose, user profiles of the users will be created under a pseudonym from the processed data. We use Google Analytics only with activated IP anonymisation. This means that the IP address of the user is truncated by Google within the member states of the European Union or in other contracting states of the Agreement on the European Economic Area. Only in exceptional cases

is the full IP address transferred to a Google server in the USA and truncated there. The IP address provided by the user's browser will not be combined with other Google data. The user can prevent the storage of cookies by configuring the browser software accordingly; the user can also prevent the collection of the data generated by the cookie in relation to the use of the website and the processing of this data by Google
